The Illinois Association of REALTORS® Past Presidents Scholarship Fund will be used to award scholarships for Illinois residents who are members of the Illinois Association of REALTORS to pursue their GRI (Graduate REALTOR® Institute) or CRB (Certified Residential Broker) designation. The number of scholarships awarded will be determined by the Foundation. The Foundation wishes to award the maximum amount of scholarships each year. Each scholarship will pay for tuition, reimbursement for actual expenses incurred, including hotel expenses and meals, may also be considered by the Foundation. Total scholarship, including tuition and reimbursement, is not to exceed \$500.

The Presidents of the Illinois Association of REALTORS® are proven leaders in Illinois' real estate industry and represent the best of Illinois REALTORS®. Their hard work and dedication to the Illinois Association of REALTORS® and the real estate industry in general is immeasurable.

The President of the Illinois Association of REALTORS® serves as the chief elected officer of the Association, representing the entire membership. The President of the Illinois Association of REALTORS® many duties include directing the other officers, presiding as chairperson over the Board of Directors and acting as chief spokesperson for the Association. The President of the Illinois Association of REALTORS® also serves as chairperson of all meetings of the Association's Board of Directors and Executive Committee as well as serving as chairperson of the Leadership Committee. As chief spokesperson for the Association they are responsible for keeping the membership, public, press, legislative bodies and similar organizations informed on issues affecting the Association and its membership.

The Foundation

The Illinois Real Estate Educational Foundation is a not-for-profit organization established to aid and promote real estate education throughout Illinois. The Foundation is supported through voluntary contributions from organizations and individuals who recognize the importance of furthering academic experience and training in the Illinois Real Estate industry.

Eligibility

Any resident of Illinois who is a member of the Illinois Association of REALTORS® is eligible to apply for a scholarship. This Scholarship cannot be used for reimbursement for previously attended courses.

SELECTION CRITERIA

The application must be completed and returned to the Foundation's office not later than October 1. Copies of letters of recommendation and reference must also be received by the Foundation's office not later than October 1. Mail all information to the Illinois Real Estate Education Foundation; P.O. Box 2607; Springfield, Illinois 62708.

The selection of scholarship recipients will be determined by the Foundation, taking into consideration the following criteria:

- The applicant's status as an Illinois resident and a member of the Illinois Association of REALTORS®;
- The applicant's references and recommendations by at least one real estate broker from the office with which the applicant is affiliated (if the applicant is from a small office a designated principle broker from another firm within the same local association may be used) and from two officers from the local Board of which the applicant is a member, one of which may be the local Board Executive Officer;
- The applicant has been a licensed real estate agent or broker for a minimum of one year, working and residing in Illinois;
- The applicant's intended course of study.

All of the following must be submitted by October 1 along with the scholarship application form: (The following checklist is for your convenience only)

_____1. A typed, signed statement of activities in your local Board, including any committee memberships or chairmanships, of your attendance at local Board meetings and functions, and of your attendance at meetings and functions of the Illinois Association of REALTORS®.

_____2. Information regarding community involvement, including details of local, state and national participation in civic and service clubs, charitable activities, political action, fraternal or religious groups.

_____3. A letter of recommendation from at least one real estate broker from the office with which the applicant is affiliated. (*Replies from the references are to be sent directly to the Foundation, are confidential, and are under no circumstances to be revealed to the candidate.*)

_____4. Letters of recommendations from two officers (one which may be the local Board Executive Officer) from the local Board of which the applicant is a member. (*Replies from these references are to be sent directly to the Foundation, are confidential, and are under no circumstances to be revealed to the candidate.*) Information could include committees on which you have served, attendance at the local Board, State Association and National Association functions.

_____5. Your personal letter providing information about why you need this particular scholarship, your plans for use of the scholarship, and your future goals as they relate to the use of this scholarship.
